**PUBLIC PATH DIVERSION ORDER 2025**

This above Order, made on the 29<sup>th</sup> January 2025 by the Vale of Glamorgan Council under Section 119 of the Highways Act 1980, will divert the public footpath running from a point at the northeast of China House NGR 292189 169245, proceeding south-westwards to a stone stile at NGR 292186 169244, then north-westwards through the garden of China House to NGR 292173 169255 and continuing south-westwards parallel and to the west side of the boundary of China House to terminate at NGR 292134 169219, to a line running from the northeast of China House NGR 292189 169245, proceeding north-westwards to a kissing gate at NGR 292176 169255, then continuing south-westwards parallel and to the west side of the boundary of China House to terminate NGR 292134 169219.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may confirm the Order as an unopposed order. If the Order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
