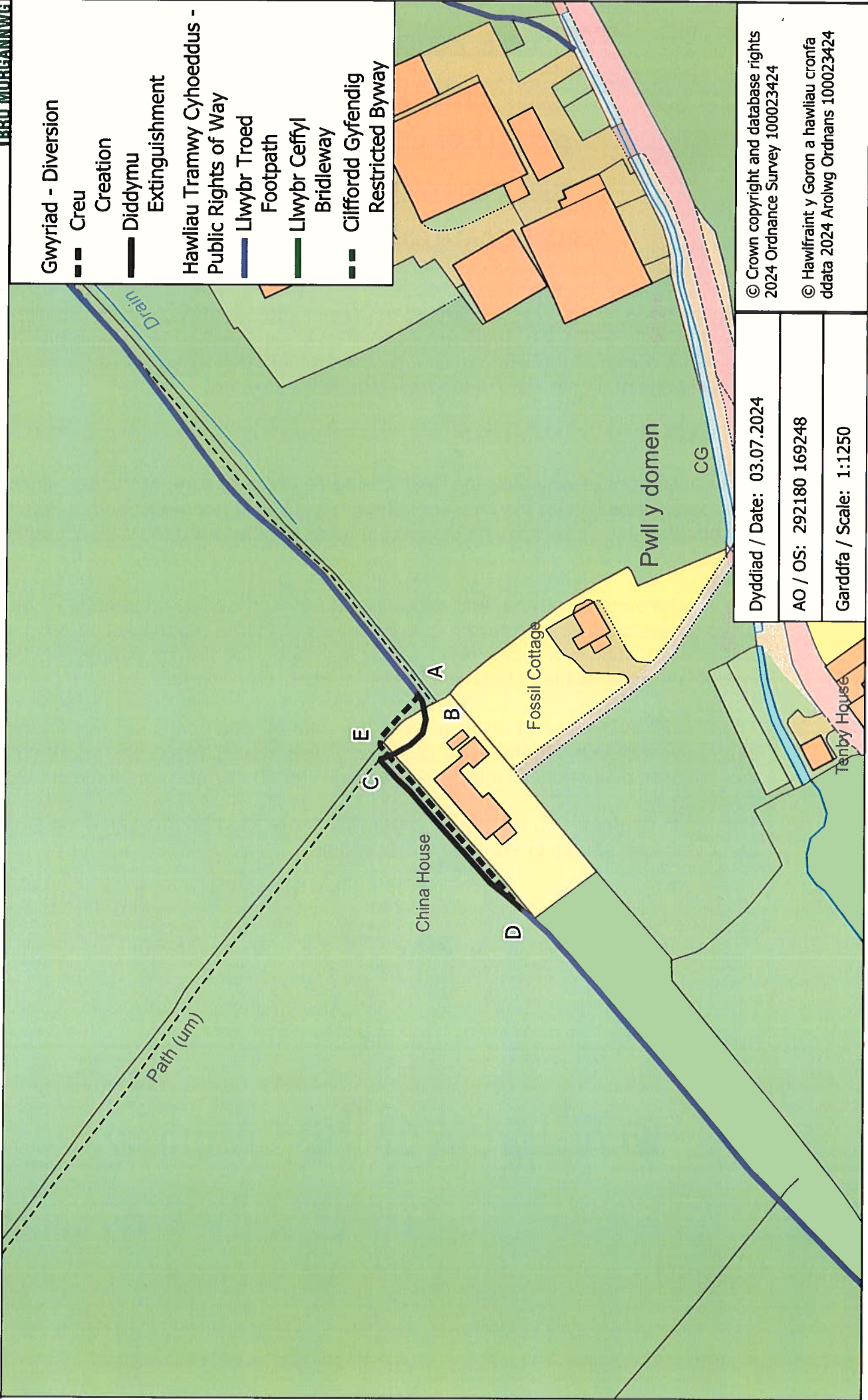
PUBLIC PATH DIVERSION ORDER 2025

This Order is made by the Vale of Glamorgan Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

BY THIS ORDER

1. The public right of way over the land situate at China House, Marcross, shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order.
2. Notwithstanding this Order any statutory undertaker having apparatus in, on, over, along or across the land referred to in paragraph 1 for the purpose of carrying on their undertaking shall have the same rights in respect of the apparatus as they had immediately before the date on which the footpath was diverted.
3. There shall at the end of 28 days from the date of confirmation of this Order be an alternative footpath over the land situate at China House, Marcross described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.
4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

The path swings north-westwards through the garden of China House to point C (NGR 292173 169255). The path continues south-westwards parallel and to the west side of the boundary of China House to terminate at point D (NGR 292134 169219).	769 metres	Undefined
