

**THE VALE OF GLAMORGAN COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND
LOADING AND PARKING) (CIVIL ENFORCEMENT)
(AMENDMENT) (No8) ORDER 2025**

1. Notice is given that the Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers proposes to make an Order to revoke in part and amend the provisions contained in the Order as specified in the Schedules below.

3. Persons objecting to the proposed Order are advised that in view of the Local Government (Access to Information) Act 1985 this Council is legally obliged to make any comments received in response to the proposed Order open to public inspection.

SCHEDULE

Insert into Map Schedules AY50, AZ50 and BA50

The following restrictions shall NOT apply, where the markings have been omitted at a gated access, a vehicular or pedestrian crossover, on any of the named roads.

**Proposed Prohibition of Waiting at Any Time Order
Ffordd Y Milenium**

On the east side from the junction with the unnamed road leading to Beacon House, southwards for a distance of approximately 91 metres.

On the east side from the junction with the unnamed road leading to the supermarket, southwards for a distance of approximately 35 metres.

On the northeast side from a point approximately 87 metres southeast of the junction with the unnamed road leading to the supermarket, south eastwards for a distance of approximately 2 metres.

On the northeast side from the junction with Ffordd Y Dociau, north westwards for a distance of approximately 98 metres.

On the northeast side from the junction with Ffordd Y Dociau, south eastwards for a distance of approximately 93 metres.

On the west side from the junction with Portland Drive, northwards for a distance of approximately 68 metres.

On the southwest side from the junction with Portland Drive, south eastwards for a distance of approximately 88 metres.

On the southwest side from the junction with Ffordd Y Glannau, north westwards for a distance of approximately 70 metres.

On the southwest side from a point approximately 83 metres northwest of the junction with Ffordd Y Glannau, north westwards for a distance of approximately 22 metres.

On the southwest side from the junction with Ffordd Y Glannau, south eastwards for a distance of approximately 96 metres.

Unnamed Road leading to Beacon House car park

On both sides from the junction with Ffordd Y Milenium, south eastwards for a distance of approximately 6.5 metres.

Portland Drive

On both sides from the junction with Ffordd Y Milenium, westwards for a distance of approximately 37 metres.

Unnamed road leading to Supermarket

On the north side from the junction with Ffordd Y Milenium, westwards for a distance of approximately 20 metres.

On the south side from the junction with Ffordd Y Milenium, westwards for a distance of approximately 13 metres.

Ffordd Y Glannau

On both sides from the junction with Ffordd Y Milenium, south westwards for a distance of approximately 15 metres.

Ffordd Y Dociau

On the northwest side from the junction with Ffordd Y Milenium, north eastwards for a distance of approximately 65 metres.

On the southeast side from the junction with Ffordd Y Milenium, north eastwards for a distance of approximately 68 metres.

On the northwest side from the junction with Clos Tear, to its junction with Heol Livesey in a north eastwards for a distance of approximately 54 metres.

On the northwest side from the junction with Heol Livesey, north eastwards for a distance of approximately 10 metres.

On the southeast side from the junction with Heol Finch, north eastwards for a distance of approximately 68 metres.

Clos Tear

On both sides from the junction with Ffordd Y Dociau, north westwards for a distance of approximately 3 metres.

Heol Finch

On both sides from the junction with Ffordd Y Dociau, south eastwards for a distance of approximately 6 metres,

Heol Livesey

On both sides from the junction with Ffordd Y Dociau, north westwards for a distance of approximately 7.5 metres.
