**THE VALE OF GLAMORGAN COUNCIL
(A4226 5 MILE LANE, BARRY) (30MPH SPEED RESTRICTION)
(TEMPORARY) ORDER 2026**

The Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulations Act 1984 (as amended), and of all other enabling powers intends in not less than seven days from the date of this Notice to make an Order, the general effect of which is as described in the schedules below:

SCHEDULE 1

No person shall cause or permit a motor vehicle to proceed at a speed greater than 30 miles per hour between the locations specified in Schedule 2 below:

SCHEDULE 2

- Location:** The section of A4226 5 Mile Lane, Barry from a point 400m north and south of the junction which leads to the property Oaklands Solar Farm. Total length of the speed reduction to span approx. 800m.
- Reason:** The restriction is being implemented in the interests of highway safety during construction works.
- Duration:** From 00.01am on Monday 8th June 2026 until 5.00pm on Thursday 31st December 2026.
