Report Title:	Agreed Syllabus for Religion, Values and Ethics in the Vale of Glamorgan
Purpose of Report:	To ensure that Cabinet considers the Agreed Syllabus for Religion, Values and Ethics in the Vale of Glamorgan as part of the new Curriculum for Wales

#### **Executive Summary:**

- The agreed syllabus sets out the details regarding teaching and learning in the mandatory element of Religion, Values and Ethics (RVE) in line with the Curriculum for Wales, for all Vale of Glamorgan Council schools and settings maintained by the Local Authority.
- The agreed syllabus for RVE in the Vale of Glamorgan has been drafted in accordance with the Curriculum and Assessment (Wales) Act 2021.
- All maintained schools in the Vale of Glamorgan Council region are required to 'have regard' to
  the agreed syllabus for Religion, Values and Ethics when designing their curriculum. The Vale of
  Glamorgan Council has a duty to review the agreed syllabus every five years.
- The Vale of Glamorgan Council agreed syllabus recognises the approach of the Curriculum for Wales Framework is based on the principle of subsidiarity and, as such, the Vale of Glamorgan Council agreed syllabus recognises and reflects the autonomy of each school and setting in realising its own curriculum.
- The Vale of Glamorgan Council agreed syllabus would take effect from 1st September, 2022.
- "Religion, values and ethics (RVE) is a statutory requirement of the Curriculum for Wales and is
  mandatory for all learners from ages 3 to 16. RVE forms part of the Humanities Area. This Area
  encompasses geography; history; religion, values and ethics; business studies. These disciplines
  share many common themes, concepts and transferable skills, whilst having their own discrete
  body of knowledge and skills." RVE Guidance

#### Recommendation

1. That Cabinet approves the recommendation of the Vale of Glamorgan Agreed Syllabus Conference (ASC) to adopt the Agreed Syllabus for Religion, Values and Ethics in the Vale of Glamorgan (Attached as Appendix A) as part of the new Curriculum for Wales.

#### **Reason for Recommendation**

1. Religion, Values and Ethics (RVE) is a statutory requirement of the Curriculum for Wales and Curriculum and Assessment (Wales) Act 2021. It is mandatory for the Council to produce and adopt an agreed syllabus for RVE which applies to all learners, from ages 3 to 16 in schools and settings maintained by the Local Authority.

#### 1. Background

- **1.1** Religion, Values and Ethics (RVE) is a statutory requirement of the Curriculum for Wales and Curriculum and Assessment (Wales) Act 2021.
- 1.2 The Curriculum for Wales provides a positive opportunity for all of those involved in education to reflect on why we teach, which concepts are important, how learners can make meaningful progression in their learning and to develop learners of the twenty-first century. It is a rich and varied curriculum encouraging the development of knowledge, skills and experiences for all learners from ages 3-16.
- 1.3 The traditional subject of 'Religious Education' has been renamed 'Religion, Values and Ethics' reflecting the broadening approach of the subject and the diversity of the population within Wales in the twenty-first century.
- 1.4 The Curriculum for Wales provides a valuable opportunity to recognise and enhance Religion, Values and Ethic's importance in the role and delivery of wider school foci, including: the development of learner's individual sense of spirituality; the prevent strategy; inclusive education and contributing to one of the four core purposes of the curriculum to become 'ethical, informed citizens of Wales and the world'.
- "As RVE is a locally determined subject, the agreed syllabus specifies what should be taught in RVE within each of the 22 Local Authorities in Wales for those schools that teach the agreed syllabus." Guidance for RVE
- 1.6 The Vale of Glamorgan Council is asked to consider and adopt the agreed syllabus for Religion, Values and Ethics following a formal recommendation to the local authority by the Agreed Syllabus Conference on 26<sup>th</sup> April, 2022.
- "Once an agreed syllabus has been adopted, all maintained schools and settings are required to have regard to the agreed syllabus including schools of a religious character, in their design of the agreed syllabus element of their RVE provision."

#### 2. Key Issues for Consideration

- Vale of Glamorgan schools and settings take note that in accordance with the Curriculum and Assessment (Wales) Act 2021 the Vale of Glamorgan Council agreed syllabus reflects that:
- the religious traditions in Wales are in the main Christian while taking account of the teaching and practices of the other principal religions represented in Wales.
- the fact that a range of non-religious philosophical convictions are held in Wales.
- Vale of Glamorgan schools and settings are also to take note of the following legislative changes which will have a significant impact on schools:
- There is no parental right to withdraw their children from the academic subject of Religion, Values and Ethics within the Curriculum for Wales.
- Maintained schools with nursery age children and funded non-maintained nursery settings must provide Religion, Values and Ethics for all their learners from age three from September 2022.
- Post 16 Religion, Values and Ethics in maintained schools is optional for post 16 learners from September 2027.

# 3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

- 3.1 The Well-being of Future Generations Act 2015 ("the 2015 Act") requires the Council to think about the long-term impact of their decisions, to work better with people, communities and each other and to prevent persistent problems such as poverty, health inequalities and climate change.
- 3.2 The Council has committed as part of the Corporate Plan 2020-2025 to achieving a vision of 'Working Together for a Brighter Future'. This plan is reflective of the Welsh Government's Well-being of Future Generations Act and is comprised of four Well-being objectives to deliver this vision:
- Objective 1 To work with and for our communities
- Objective 2 To support learning, employment and sustainable economic growth
- Objective 3 To support people at home and in their community
- Objective 4 To respect, enhance and enjoy our environment
- 3.3 To make sure we are all working towards the same purpose, the 2015 Act puts in place seven well-being goals on the Council. The 2015 Act makes it clear the listed public bodies must work to achieve all of the goals, not just one or two, these being:
- A prosperous Wales
- A resilient Wales
- A healthier Wales

- A more equal Wales
- A Wales of cohesive communities
- A Wales of vibrant culture and Welsh Language
- A globally responsible Wales
- 3.4 Support for schools in relation to the curriculum contributes to the Council's Wellbeing Objectives drawn from the Corporate Plan 2020-25. There is specific alignment with our wellbeing objectives to work with and for our communities and to support learning, employment and sustainable economic growth.
- 3.5 This report recognises the importance of involving pupils, staff, parents, governors, and members of the local community to participate and engage with schools in developing their vision and curriculum design.
- This report outlines how partnership work is supporting schools in engaging with professional learning opportunities and elements of curriculum design. It recognises the need for education provision to be flexible and responsive to future needs.

#### 4. Climate Change and Nature Implications

**4.1** There are no direct climate change or Nature implications as a result of this report.

#### 5. Resources and Legal Considerations

#### **Financial**

5.1 The drafting of the agreed syllabus for RVE has been delivered within existing resources. Proposals for future development will be subject to consultation and Cabinet approval where necessary.

**5.2** There are no direct employment implications as a result of this report.

#### **Legal (Including Equalities)**

- **The Curriculum and Assessment (Wales) Act 2021, Schedule 2, para 7** amends the Education Act 1996 by inserting (after section 375) a new section 375A
  - 375A Agreed syllabus of Religion, Values and Ethics: Wales
  - (1) Each Local Authority in Wales must adopt a syllabus of Religion, Values and Ethics for use in the schools maintained by them.
  - (2) The syllabus adopted by an Authority may make different provision in respect of—

- (a) different descriptions of school maintained by the Local Authority;
- (b) different descriptions of pupils.

#### (3) The syllabus—

- (a) must reflect the fact that the religious traditions in Wales are in the main Christian while taking account of the teaching and practices of the other principal religions represented in Wales;
- (b) must also reflect the fact that a range of non-religious philosophical convictions are held in Wales.
- (4) In subsection (3), the reference to philosophical convictions is to philosophical convictions within the meaning of Article 2 of the First Protocol to the European Convention on Human Rights.
- (5) Schedule 31 makes further provision in relation to a syllabus of Religion, Values and Ethics.
- (6) In this section—

"the European Convention on Human Rights" means the Convention for the Protection of Human Rights and Fundamental Freedoms, agreed by the Council of Europe at Rome on 4th November 1950, as it has effect for the time being in relation to the United Kingdom;

"the First Protocol", in relation to that Convention, means the protocol to the Convention agreed at Paris on 20th March, 1952.

- (7) References in this Act to an agreed syllabus, in relation to Wales, are to a syllabus adopted under this section, or deemed to be adopted under this section by virtue of paragraph 14(2) of Schedule 31; and accordingly in relation to a syllabus deemed to have been so adopted, any reference to the date on which an agreed syllabus was adopted is a reference to the date of deemed adoption specified by the Welsh Ministers in a direction under that paragraph.
- (8) In exercising functions under this section, a Local Authority must have regard to any guidance given by the Welsh Ministers.

#### Foreword **Foreword**

The Curriculum for Wales provides a positive opportunity for all of those involved in education to reflect on why we teach, which concepts are important, how learners can make meaningful progression in their learning and to develop learners of the twenty-first century. It is a rich and varied curriculum encouraging the development of knowledge, skills and experiences for all learners from ages 3-16. Religion, Values and Ethics (RVE) is one of the mandatory subjects of this curriculum. It is an exciting and pivotal time for the subject as it moves to be within the curriculum, for the first time, as part of the Humanities Area of Learning. Whilst part of the Humanities Area, encompassing geography; history; religion, values and ethics; social studies and business studies, these disciplines share many common themes, concepts and transferable skills whilst having their own discrete body of knowledge and skills. 'RVE' incorporates a range of disciplinary approaches that can be used by learners to engage critically with a broad range of religious and non-religious concepts. For example, disciplinary approaches relevant to RVE may include religious studies, philosophy, theology, sociology, psychology, and anthropology.

The traditional subject of 'Religious Education' has been renamed 'Religion, Values and Ethics' reflecting the broadening approach of the subject and the diversity of the population within Wales in the twenty-first century. We all have a crucial part to play to inspire our learners to widen their knowledge, skills and experiences within Religion, Values and Ethics. This is both an exciting and challenging opportunity to promote objective, critical and pluralistic studies, encouraging enquiry and investigation into religious and non-religious philosophical convictions within society on a local, national and global platform. Our learners will develop the skills for life-long learning and interest, preparing them for life beyond the school setting.

Schools and settings within the Vale of Glamorgan are seizing opportunities to develop rich, dynamic and innovative RVE within an autonomous school designed curriculum, appropriate for their learners. All schools and settings, within the region, will have 'regard to' their locally agreed syllabus for RVE when designing and implementing their curriculum, following the legislation requirements.

The Curriculum for Wales provides a valuable opportunity to recognise and enhance Religion, Values and Ethic's importance in the role and delivery of wider school foci, including: the development of learner's individual sense of spirituality; the prevent strategy; inclusive education and contributing to one of the four core purposes of the curriculum to become 'ethical, informed citizens of Wales and the world'. All schools and settings within the Vale are developing provision for RVE that prepares their learners for life and work in a fast-changing and diverse world, as responsible and informed citizens.

I would like to take this opportunity to extend my gratitude to everyone who has been involved in the creation of this agreed syllabus and to those who will subsequently continue to provide support. I would also like to personally thank the practitioners within the Vale of Glamorgan who I know have worked tirelessly in the preparation of this new curriculum and who will continue to provide the very highest level of teaching and learning experience for all our learners.

# The Vale of Glamorgan Council agreed syllabus for Religion, Values and Ethics

#### **Audience**

The Vale of Glamorgan Council Religion, Values and Ethics agreed syllabus has been written to be accessible to all those responsible for designing and delivering the Religion, Values and Ethics curriculum. The intended audience includes:

- the headteacher of a maintained school or a maintained nursery school
- the governing body of a maintained school or a maintained nursery school
- a provider of funded non-maintained nursery education
- the teacher in charge of a pupil referral unit
- the management committee for a pupil referral unit
- a person who provides teaching and learning for a child, otherwise than at a maintained school, maintained nursery school or pupil referral unit, by virtue of arrangements made under section 19A of the Education Act 1996 (c. 56)
- a local authority in Wales

In addition, the agreed syllabus may also be useful to practitioners, regional consortia, awarding bodies, Estyn, teacher unions, religious organisations, non-religious organisations, parents and carers and other bodies in Wales with an interest in Religion, Values and Ethics.

#### **Overview**

#### Agreed syllabus

"As RVE is a locally determined subject, the agreed syllabus specifies what should be taught in RVE within each of the 22 local authorities in Wales for those schools that teach the agreed syllabus." Guidance for RVE

This document sets out the details regarding teaching and learning in the mandatory element of Religion, Values and Ethics (RVE) in line with the Curriculum for Wales, for all Vale of Glamorgan Council schools and settings maintained by the local authority. This document has been adopted as the agreed syllabus for Religion, Values and Ethics in the Vale of Glamorgan, in accordance with the Curriculum and Assessment (Wales) Act 2021.

The Vale of Glamorgan Council has adopted this document as the agreed syllabus for Religion, Values and Ethics in May 2022, following a formal recommendation to the local authority by the Agreed Syllabus Conference on the 26<sup>th</sup>April 2022.

"Once an agreed syllabus has been adopted, all maintained schools and settings are required to have regard to the agreed syllabus including schools of a religious character, in their design of the agreed syllabus element of their RVE provision." Guidance for RVE

All maintained schools in the Vale of Glamorgan Council region are required to 'have regard' to the agreed syllabus for Religion, Values and Ethics when designing their curriculum. The Vale of Glamorgan Council has a duty to review the agreed syllabus every five years.

The Vale of Glamorgan Council agreed syllabus recognises the approach of the Curriculum for Wales Framework is based on the principle of **subsidiarity** and, as such, the Vale of Glamorgan Council agreed syllabus recognises and reflects the autonomy of each school and setting in realising its own curriculum.

#### **Implementation**

This Vale of Glamorgan Council agreed syllabus will be effective from the **1st** of **September 2022**, for Religion, Values and Ethics for all learners, up to and including Year 6. For Year 7 learners, schools in the region will have flexibility on whether to roll out the Curriculum for Wales in September 2022, or to roll out the Curriculum for Wales for Years 7 and 8 together in September 2023. During the period of curriculum roll out, as a secondary school or setting 'adopts' the Curriculum for Wales Framework for a particular year group, this Vale of Glamorgan Council agreed syllabus will supersede the current/legacy Vale of Glamorgan Council Agreed Syllabus. From September 2023, this new agreed syllabus, will be effective for all learners, up to and including Year 8, as all schools and settings will have implemented the Curriculum for Wales for those learners. Thereafter, the phased roll-out of the Curriculum for Wales will continue, and this Vale of Glamorgan Council agreed syllabus will supersede the other:

- year 9 learners in September 2024
- year 10 learners in September 2025
- year 11 learners in September 2026

More information for schools and settings on the process for opting in to the Curriculum for Wales in respect of Year 7 learners is provided in the 'Journey to curriculum roll-out'.

# The Vale of Glamorgan Council Agreed Syllabus for Religion, Values and Ethics

#### Introduction

The Vale of Glamorgan Council welcomes that Religion, Values and Ethics is a **statutory** requirement of the Curriculum for Wales and is **mandatory** for all learners from ages 3 to 16:

#### Mandatory

"Religion, values and ethics (RVE) is a statutory requirement of the Curriculum for Wales and is mandatory for all learners from ages 3 to 16. RVE forms part of the Humanities Area. This Area encompasses geography; history; religion, values and ethics; business studies. These disciplines share many common themes, concepts and transferable skills, whilst having their own discrete body of knowledge and skills." RVE Guidance

#### The legal requirements of Religion, Values and Ethics (RVE)

It is essential that Headteachers, senior leaders and governors understand the legal requirements of RVE within the Curriculum for Wales. These can be found in the RVE section of the Summary of legislation.

   Values and Ethics within the Curriculum for Wales
- Maintained schools with nursery age children and funded non-maintained nursery settings must provide Religion, Values and Ethics for all their learners from age three from September 2022
- Post 16 Religion, Values and Ethics in maintained schools is optional for post 16 learners from September 2027

#### **Designing your RVE Curriculum**

The starting point for any curriculum design is <u>Hwb</u>. Any changes will also be made centrally on Hwb, so it is advised that you read and check information on the <u>Curriculum for Wales</u> regularly.

Each school and setting will need to decide how Religion, Values and Ethics best works within their approach to the Humanities Area. For example, curriculum design can be integrated, multidisciplinary, interdisciplinary or disciplinary. Curriculum design should be evaluated regularly in line with the Curriculum for Wales Framework. All schools and settings must also have regard to this locally agreed syllabus for Religion, Values and Ethics when designing their curriculum.

The area on the <u>Humanities Area of Learning Experience (Area)</u> is also crucial for designing your Religion, Values and Ethics curriculum.

Here you will find the following areas:

- 1. Introduction
- 2. Statements of what matters (mandatory)
- 3. Principles of progression (mandatory)
- 4. Descriptions of learning
- 5. <u>Designing your curriculum</u>

The section on 'designing your curriculum' has the following information that you will also find useful:

- Cross-curricular skills and integral skills
- Specific considerations for this Area
- Key links with other Areas
- Cross-cutting themes

#### Other Areas of the RVE Guidance

#### Suggested points to consider for Vale of Glamorgan Schools and Settings

It is advised that the following questions, from the <u>RVE Guidance</u> on Hwb, can be useful when designing your curriculum for Religion, Values and Ethics:

- Have you considered how RVE will work best within the Humanities Area?
- Have you had regard for your agreed syllabus for RVE?
- Does your curriculum design for RVE support the realisation of the four purposes?
- Have you used the statements of what matters for this Area to inform your curriculum design?
- Have you used RVE concepts in your curriculum design?
- Have you considered a range of sub lenses through which to view RVE concepts to support curriculum design?
- Have you considered learning progression in RVE, using the principles of progression and descriptions of learning in the Humanities Area?
- Have you considered the 'learning journeys' provided to support your understanding of progression in relation to RVE?
- Have you reflected on the possible learning journeys of your own learners to support curriculum design for RVE?
- Have you included opportunities in your curriculum design for enriching learner experiences in RVE?
- Have you made key links between RVE and the other areas of learning and experience?
- Have you included opportunities for learners' spiritual development in RVE?
- Does your curriculum design for RVE ensure an appropriate depth, breadth and quality of learning?

#### The 'Right to Withdraw' in the Curriculum for Wales

"There is **no** parental right to request that a child is withdrawn from RVE in the Curriculum for Wales." RVE Guidance

In the Curriculum for Wales Religion, Values and Ethics is a **statutory** requirement for all learners from age 3 to 16. The timetable for these changes is as follows:

Primary aged learners – September 2022

Year 7 learners – September 2022 OR September 2023, depending on when the school/setting rolls out the Curriculum for Wales

Year 8 learners – September 2023

Year 9 learners – September 2024

Year 10 learners – September 2025

Year 11 learners - September 2026

This is in line with every other academic subject in the Curriculum for Wales.

Note that parents may still request that their children are withdrawn from 'collective worship' from September 2022, if they wish, as this is distinct and separate from the academic subject of Religion, Values and Ethics.

#### Additional supporting materials for Vale of Glamorgan schools and settings

The Vale of Glamorgan Council and the Vale of Glamorgan Standing Advisory Council for RVE (SAC) will continue to provide supporting materials, in addition to this agreed syllabus. These will be regularly updated and are designed to provide ongoing support for practitioners.
