C163 ANNOUNCEMENT –

The Leader welcomed all parties to the Cabinet meeting and reminded everyone present that the meeting was being Live Streamed as well as recorded via the internet and this recording archived for future viewing.

She asked if all participants please 'mute' themselves when not speaking in order to avoid any background noise or feedback when other participants were speaking, and if a participant wished to speak if they could put their hand up (to be seen on screen) or use the 'raise hand' function.

Members were asked to ensure that all debate was raised verbally and not via the 'chat' function for the sake of the recording. The 'chat' function could be used to highlight any technical issues and/or to get the attention of the Chair or Democratic Services Officer.

The Leader commented regarding the news that as part of an extra £227m funding package for Local Authorities across Wales that the Vale of Glamorgan Council would receive a rise in its annual settlement from Welsh Government of 8.9%. It recognised the significant financial pressures Local Authorities in Wales were facing, but also the vital roles that Councils played in supporting their communities. While applauding its commitment to local services, it had to be recognised that Welsh Government had finite resources and unfortunately it would not resolve the whole £38m of pressures in the Council's budget, which remained in a very challenging position. Some difficult decisions lay ahead, and as ever, the priority would be to protect the essential services relied upon by the most vulnerable residents. The Council would be working over Christmas and New Year to understand what the news meant in terms of financial planning as the Council's budget setting process continued. As proposals became clearer, the Council would launch a public consultation through January and February before any plans are finalised in March. The Leader hoped that as many Vale residents as possible would take part in that consultation so that all views and contributions were heard.

As it was the last Cabinet meeting of 2022, the Leader wished everyone in the Vale of Glamorgan an enjoyable Christmas and a happy, healthy and peaceful New Year.

Although many would be spending the festive period with family and friends, there were many others across the Vale of Glamorgan it would was business as usual, for example, domiciliary carers and those working within our local care homes would be juggling time off with looking after our most vulnerable residents. The Council's Waste and Recycling Team would still be collecting whatever the weather, and other essential services would be available. Local shops, pubs and restaurants would still be providing services and needed support over the festive period. The role of the farming community was not to be overlooked, as was the essential service provided by the RNLI, Coast Guards, AA and RAC, Police, Fire and Ambulance Services. On behalf of the Cabinet and the Vale of Glamorgan Council, the Leader thanked anyone helping to support others over the festive period.

C167 UK SHARED PROSPERITY FUND - (EL/PR) (SCRUTINY – ENVIRONMENT AND REGENERATION) –

The Leader presented the report, the purpose of which was to update Cabinet on the UK Shared Prosperity Fund, and to delegate specified powers to named Officers in consultation with the relevant Portfolio Holder relating to the local delivery of the emerging Investment Plan.

As the definitive details of the programme were yet to be received, the report sought to approve the various delegations that would be required in preparation for receipt of the final details.

- (3) T H A T the Director of Place (in consultation with the Head of Finance/ Section 151 Officer and the Monitoring Officer/Head of Legal and Democratic Services) be authorised to negotiate terms and conditions for the appointment of third party suppliers/providers for internal and externally commissioned projects.
- (4) T H A T the Monitoring Officer/Head of Legal and Democratic Services (in consultation with the Head of Finance/Section 151 Officer) be authorised to prepare, complete and execute the required legal documentation to enable third party suppliers/providers to be appointed for internal and externally commissioned projects.
- (5) T H A T delegated authority be granted to the Director of Place (in consultation with the Executive Leader and Cabinet Member for Performance and Resources, the Chief Executive, Head of Finance/Section 151 Officer and Monitoring Officer/Head of Legal and Democratic Services) to approve governance and resources structures to assess and determine applications from third parties to use the UK Shared Prosperity Fund Allocation.

C168 COUNCIL TAX BASE: 2023/24 - (EL/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The Leader presented the report, the purpose of which was to seek approval for the Council Tax Base for 2023/24, agreeing the number of properties at Band D level that Council Tax would be based upon and submitted to Welsh Government by 6th January, 2023.

Councillor Wilson said that the detail provided a good indication of the size of communities and the basis for working out the precepts for the Town and Community Councils.

C169 COST OF LIVING SUPPORT FOR FOOD, WARM SPACES AND OTHER MEANS OF SUPPORT - (EL/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES AND HOMES AND SAFE COMMUNITIES) –

The Leader presented the report, the purpose of which was to present an overview of the work the Council had undertaken to address the cost of living crisis. This included help to improve access to food across the Vale of Glamorgan and outline how this work and funding opportunities connected with providing a Warm Welcome this winter, other work to assist people struggling with the rising cost of living and to raise awareness of the recent Audit Wales 'Time for change – poverty in Wales' report and the Council's proposed response.

The Leader referred to Paragraph 2.6 of the report and that she had been provided with updated figures to the published table, as follows:-

C170 A VISITOR LEVY FOR WALES – VALE OF GLAMORGAN COUNCIL - (DL/SP) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The Deputy Leader presented the report, the purpose of which was to establish the Council's current intentions on introducing the Tourism Tax and provide a response to the current Welsh Government consultation on the proposed introduction of a discretionary Visitor Levy in Wales.

It had been noted that the consultation document focussed on staying visitors rather than where the dominant visitor type was the day visitor. The consultation document allowed for feedback highlighting that issue to be raised.

The Deputy Leader said that the 'Elected Member and Officer Consultation' section of the report advised that the report be referred to the relevant Scrutiny Committee, which would of course be the case at the appropriate time.

This was a matter for Executive decision.

Cabinet, having considered the report and all the issues and implications contained therein

RESOLVED -

- (1) THAT the update on the current Welsh Government consultation on the proposed introduction of a discretionary Visitor Levy in Wales be noted.
- (2) T H A T the current Welsh Government proposals for the introduction of a Visitor Levy in Wales be considered and agreed that in light of the current economic difficulties facing the industry the current position would be to not introduce a levy in the Vale of Glamorgan and that this be used to inform the response to the Welsh Government Consultation.
- (3) THAT the Council would periodically keep under review options for a Visitor Levy, should the legislation be enacted and having regard to the economic conditions at the time of that review.

- (1) To inform Cabinet of the current consultation.
- (2) To establish the Vale of Glamorgan's current position on the introduction of the Visitor Levy, and to provide a response to the current consultation.
- (3) To allow further consideration of a Visitor Levy in the Vale of Glamorgan in the future should economic or other conditions change.

C171 SCHOOL ADMISSION ARRANGEMENTS 2024/25 - (EAWL) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The Cabinet Member presented the report, the purpose of which was to seek Cabinet approval to consult on the Local Authority's school admission arrangements as required by the Welsh Government's School Admission Code issued in July 2013.
