Executive Summary:

• To consider an application under the Licensing Act 2003 ("the Act") for the grant of a Premises Licence at Sea View Convenience Store, Unit 1 Esplanade Buildings, Friars Road, Barry, CF62 5TJ, submitted by Personal Licence Training Limited on behalf of Mr Ranjit Singh.

Recommendations

1. The Sub-Committee is required to determine the application having regard to the Council's Statement of Licensing Policy, the Guidance issued by the Home Office, the application and any representations submitted.

If minded to grant the application, the Sub-Committee is requested to confirm whether any additional conditions are to be imposed or only those which are consistent with and set out in the operating schedule. Section 10 of the Home Office Guidance relates to conditions attached to Premises Licences. Mandatory conditions apply to the licence in respect of a Designated Premises Supervisor, age verification policy and authorisation by personal licence.

Reason for Recommendations

1. To advise the Members of the relevant options available to them under the Licensing Act 2003 in determining the matter.

1. Background

1.1 The Licensing Act 2003 centres around four licensing objectives. The objectives are:

The prevention of crime and disorder Public Safety
The prevention of public nuisance
The protection of children from harm

- **1.2** Current status of premises.
- 1.3 A premises licence was in force for Unit 1 Esplanade Buildings issued under the Licensing Act 2003 and operated in the style of a café and bar. Whilst that licence had been surrendered by the previous holder, it was reinstated by way of transfer of licence and the licence holder is Mr Ranjit Singh. Whilst a premises licence is currently in force, it does not prevent the Sub-Committee from considering a fresh application from Mr Singh for the grant of a licence in the circumstances set out below.
- 1.4 On 15th July 2021 Licensing Officers visited and found the premises was closed and being refurbished as a shop. The officers spoke to a member of staff who said that they were planning to open in September. Advice was given that the new owner should contact licensing in regard to the Premises Licence.
- On 29th July 2021 Licensing were advised by South Wales Police that the premises were open as a shop and selling alcohol. The report of the Officer who attended the premises was sent by email and photographs were included. A copy of the email and photographs is attached at Appendix A.

- 1.6 Later that day Officers from Licensing and South Wales Police visited the premises. There was clearly a large stock of alcohol in the shop although following a previous visit by Police Officers, it had mostly been covered and was not being sold.
- 1.7 Mr Ranjit Singh, the new owner and applicant, was advised that he would need to apply for a new licence as, due to the changes in layout and type of business, he would not be able to comply with the conditions of the licence were he to open the shop and sell alcohol to the public.
- 1.8 On 18th August 2021 the Licensing Authority received an application for the grant of a Premises Licence for Sea View Convenience Store, Unit 1 Esplanade Buildings, Friars Road, Barry, CF62 5TJ. A copy of the relevant parts of the application form is attached at Appendix B to this Report.

2. Key Issues for Consideration

- **2.1** Application process
- The application was advertised in accordance with the regulations. The period for making representations ended on 15th September 2021.
- 2.3 Under The Licensing Act 2003 (Premises and Club Premises Certificates)
 Regulations 2005 a Responsible Authority or any other person may make relevant representations at any time during the 28 day consultation period.
- 2.4 On 14th September 2021 a representation was received from South Wales Police. A copy of the representation is attached to the Report at Appendix C.
- 2.5 Nine representations were received from other persons during the consultation period. A copy of the representations is attached to the Report at Appendix D. The representations have been anonymised for the purposes of publication of this report.
- 2.6 The authority is only empowered to consider relevant representations as defined in Section 18 (6) of the Licensing Act 2003 that is, "representations which are about the likely effect of the grant of the premises licence on the promotion of the licensing objectives" which are not deemed frivolous or vexatious.
- **2.7** A Premises Licence, once granted, will generally remain in force indefinitely. The circumstances in which it will not do so are when:

It is revoked; or The applicant requests a licence for a limited time only; or It is suspended; or

- It lapses due to some incapacity on the part of the licence holder; or It is surrendered.
- 2.8 This matter has been referred to a Sub-Committee for determination as officers do not have the delegated authority to determine applications where relevant representations have been received and not withdrawn.
- **2.9** Operating Schedule
- **2.10** Applicants are required to complete the Operating Schedule set out in the application form. The importance of the operating schedule is that it not only sets out the steps the applicant intends to take to promote the licensing objectives, but these steps will be also translated into conditions of licence, if the application is approved.
- 2.11 The Guidance issued under Section 182 of The Licensing Act 2003 makes a number of recommendations to assist applicants in completing the Operating Schedule. They include point 8.41 that requires that applicants 'be aware of the expectations of the licensing authority and the responsible authorities as to the steps that are appropriate for the promotion of the licensing objectives, and to demonstrate knowledge of their local area when describing the steps they propose to take to promote the licensing objectives.'
- 2.12 It further states that 'applicants are also expected to undertake their own enquiries about the area in which the premises are situated to inform the content of the application'.
- **2.13** Point 8.42 of the statutory guidance states;
- 2.14 Applicants are, in particular, expected to obtain sufficient information to enable them to demonstrate, when setting out the steps they propose to take to promote the licensing objectives, that they understand:
 - the layout of the local area and physical environment including crime and disorder hotspots, proximity to residential premises and proximity to areas where children may congregate;
 - any risk posed to the local area by the applicants' proposed licensable activities; and
 - any local initiatives (for example, local crime reduction initiatives or voluntary schemes including local taxi-marshalling schemes, street pastors and other schemes) which may help to mitigate potential risks.
- 2.15 Whilst the Operating Schedule of this application includes a number of widely used conditions, it does not make any reference to the location or local circumstances of the area the premises is situated.
- **2.16** Background information

- 2.17 A number of the representations make reference to the Public Spaces Protection Order in force in Barry Island. For information, Barry Island Seafront has been covered by a Public Space Protection Order (PSPO) since September 2017. The Order was renewed by Council on 7 December 2020 and a copy of the Current Order and relevant Map attached to this report at Appendix E.
- 2.18 In terms of the representations received, Members are advised that the adoption of a PSPO does not have the effect of banning the sale or consumption of alcohol in an area which it covers.
- 2.19 However, the Council must be satisfied with certain conditions prior to adopting a PSPO; in summary that alcohol related anti-social behaviour and criminal activities have been carried out within the specified areas. It must also be able to demonstrate that this behaviour has a detrimental effect on the quality of life of those in the locality, and it is likely that these activities will be carried out within the designated area.
- 2.20 In addition, the Council must also be satisfied that the effect or likely effect of the activities is, or is likely to be, of a persistent or continuing nature and that these activities are unreasonable and justify the restrictions imposed by this Order and that it is in all the circumstances expedient to make this Order for the purpose of reducing crime and/or anti-social behaviour in a public place. The full details are attached for information in Appendix E.

3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

4. Resources and Legal Considerations

4.1 Fees associated with the issue of Licences are set in statute and support the administration and enforcement of the Licensing Act 2003 functions.

Legal (Including Equalities)

4.3 Section 18 of the Licensing Act 2003 provides as follows;

- 18 Determination of application for premises licence
- (1) This section applies where the relevant licensing authority—
- (a) receives an application for a premises licence made in accordance with section 17, and
- (b) is satisfied that the applicant has complied with any requirement imposed on him under subsection (5) of that section.
- (2) Subject to subsection (3), the authority must grant the licence in accordance with the application subject only to—
- (a) such conditions as are consistent with the operating schedule accompanying the application, and
- (b) any conditions which must under section 19, 20 or 21 be included in the licence.
- (3) Where relevant representations are made, the authority must—
- (a) hold a hearing to consider them, unless the authority, the applicant and each person who has made such representations agree that a hearing is unnecessary, and
- (b) having regard to the representations, take such of the steps mentioned in subsection (4) (if any) as it considers necessary for the promotion of the licensing objectives.
- (4) The steps are—
- (a) to grant the licence subject to—
- (i) the conditions mentioned in subsection (2)(a) modified to such extent as the authority considers necessary for the promotion of the licensing objectives, and
- (ii) any condition which must under section 19, 20 or 21 be included in the licence;
- (b) to exclude from the scope of the licence any of the licensable activities to which the application relates;
- (c) to refuse to specify a person in the licence as the premises supervisor;
- (d) to reject the application.
- 4.4 The Licensing Authority has therefore determined that the application meets the requirements of both the Licensing Act 2003 and its Guidance and can be processed accordingly.
- 4.5 The Licensing Act 2003 Sub-Committee should have regard to the Vale of Glamorgan Council's Statement of Licensing Policy, and pay particular attention to Sections 3, 7, 8, 12 and 20. There are no specific policies relating to the area for this type of application.

Evening,

It is with disappointment that I write this evening. On Friars Road Barry Island there was a premises known as Coffee Cove.

As I understand it the proprietor, had difficulties and ceased trading a while ago.

Over the past few weeks we have observed a team of workers in the building. We have had interaction with the people who explained that the building was being turned in to a shop that was going to sell groceries and alcohol. Checks were made with Vale of Glamorgan licencing who explained that no licence had been applied for.

The weeks have past and the shop has opened, as the SEA VIEW STORES, several days ago.

We attended at 9:20 this evening, due to the concerning amount of alcohol that was clearly visible, when driving past the store.

On entering the store, officers witnessed the sale of alcohol to members of the public.

There was no licence displayed in the shop. I asked for the licence. The Owner Ranjit Singh . . .

went outside and returned with a premises licence in the name of whom they state has no interest in

the new business. They do not have a licence.

(DETAILS OF LICENCE HELD PICTURED BELOW)

The shop layout is as you will see from the attached photographs mainly alcohol sales. There is more alcohol to food/groceries. It is clear that this shop has been set up mainly to supply off sales alcohol to visitors.

Alongside the counter was a baseball bat although staff claimed that this had been found outside.

This shop is quite concerning and appears to be operating outside of the law. They have said they won't sell any more until they have a new licence however they are open and operating. I respectfully request that this matter is looked in to as a matter of urgency.

Also consideration regarding this premises opening within a PSPO area, with the issues Barry island currently holds, involving underage drinking and ASB.

I have real concerns for the future of Barry Island, if this current premises is granted an off sales licence.

- 1. Strict implementation of challenge 25 policy
- 2. CCTV to be installed and 31 days recoding system
- 3. All staff to be trained in responsible alcohol retailing

b) The prevention of crime and disorder

- 1. The premises shall install and maintain a comprehensive CCTV system which records 24 hours a day. All CCTV recordings shall be stored for a minimum period of 31 days and all recordings will be stamped with the correct date and time. Viewing of recordings shall be made available, subject to Data Protection legislation, immediately upon the request of Police or an authorised council officer.
- 2. That licensing activities are only carried out at the premises at times when the CCTV system is fully operational
- 3. A staff member from the premises who is conversant with the operation of the CCTV system shall always be on the premises when the premises are open. This staff member must be able to provide a police or authorised council officer copies of recent CCTV images or data with the minimum of delay when requested.
- 4. An incident logbook will be maintained by the premises that details incidents of note that occur in the premises. This shall include refused sales, disorder, and ejections as a minimum. The logbook shall always be kept on the premises, for a minimum of 1 year from each entry, and be available for inspection, at all times the premises is open. Management shall regularly check the book to ensure all staff are using it.
- 5. All staff responsible for selling alcohol shall receive regular training in the Licensing Act 2003. Written records of this training shall be retained and made available for inspection to Police or Council Officers on request.
- 6. All alcohol shall be purchased from AWRS registered cash & carry and wholesalers.
- 7. Incident book shall be available on premises, shall be updated as and when needed.
- 8. All staff will have right to work in uk documents checked before being offered employment.

c) Public safety

- 1. Installation of appropriate safety equipment
- 2. Fire exit signs displayed
- 3. To comply with all current, fire, health and safety laws
- 4. CCTV working at all times

d) The prevention of public nuisance

- 1. Notice displayed asking customers to leave quietly from premises also customers will be told in person to leave quietly and not to disturb the local neighbourhood
- 2. Strict policy in place to tell all staff not to serve alcohol to drunks at all
- 3. Appropriate signage will be displayed, in prominent position informing customers they are being recorded on CCTV

e) The protection of children from harm

- 1. A challenge 25 policy will be in force, where any person looking under the age of 25 shall be asked to prove their age when attempting to purchase alcohol and signs to this effect will be displayed at the premises. Challenge 25 posters displayed where alcohol is sold.



Adding an off-licence and thus making alcohol more readily available would significantly undermine the licensing objectives and would likely lead to increased demand on the local Policing teams.

A cursory search of South Wales Police systems shows the following number of alcohol related incidents reported at selected locations on Barry Island since 1st January 2019. I have gone back to this date to compensate for the periods of time where licenced premises were closed and members of the public were restricted in their movements due to the Covid restrictions throughout 2020.

- The Promenade, 34 incidents;
- Friars Road, 32 incidents;
- Railway Station, 2 incidents, (British Transport Police may hold further figures);
- Paget Road, 42 incidents;
- Station Approach Road, 10 incidents.

Ahead of any hearing before the licensing sub-committee, these incidents will be further reviewed with a selection being presented as part of the Police evidence.

Furthermore, the area has a newly issued Public Space Protection Order (PSPO), introduced by the Vale of Glamorgan council in 2020. The PSPO being introduced is an effort to tackle the alcohol related anti-social behaviour and disorder that was occurring in the locality. This is the second time that a PSPO has been installed for Barry Island, with the original being issued in 2016.



POLICE REPRESENTATION

The Police object to the granting of this application and should the committee be minded to grant it, then they do so without the support of South Wales Police.

The Barry Island area, in particular the promenade and surrounding roads, already sees a significant upturn in demand for Police resources through the spring and summer season, with officers regularly having to deal with intoxicated persons.

There are no conditions that the applicant could propose to have on their licence that would alleviate the Police concerns around alcohol being made readily available.

Dear Sir / Madam.

I am one of the founding members of the Beautiful Barry community group. We would be very grateful if you could give consideration to our concerns as you decide on the licensing application for the Seaview onvenience store on \text{\text{rry sland}}

We are very concerned at the prospect of a license being granted at a premises on Friars Road on Barry Island. The premises in question used to called The Coffee Cove, and as the name suggests, sold coffee and snacks, alongside a range of alcoholic drinks. The business was well run, holding popular open mic nights, and alcohol was consumed at both indoor and outdoor seating. It was a lovely place for responsible socialising.

The current owners call the business a convenience store, and when they first opened, tried to sell alcohol. Over half the shop was dedicated to cheap alcohol of all types, barbeques, pop and sweets, with no seating available to consume any alcohol bought. The obvious intention was to sell cheap alcohol to be consumed on the beach, the headlands or in the gardens.

This is a dangerous prospect, encouraging binge drinking and associated anti social behaviours. Already, many events on the Island this summer were marred by such binge drinking on the beach and headlands, leading to staff being abused on the Island, an increase in litter such as smashed bottles and cans, arguments leading to fights which had to be broken up by police, and intoxicated people needing to be rescued by the RLNI and the Coastguard. Certain areas became no-go areas for the public - such as the rocks near Friars Point - and even on the main beach the alcohol abuse was so bad that families had to stay away.

And this was before this shop was up and running as a convenient, cheap way to get alcohol on the Island. People had to bring their own drink over, probably stopping at Asda on the way. They could and often were intercepted by police at the entrance to the Island. What it will be like if this cheap alcohol is availabe only a few metres from the beach is very worrying - it cannot be good.

The impression it would give to responsible visitors is not good, and the message it will send out is that binge drinking is acceptable.

It cannot be fair for the other traders who work hard to provide a convivial environment, and it certainly won't be welcome to those who will have to deal with the increased anti social behaviours which will ensue.

Visitors can still enjoy a drink in the sun during and at the end of the day in one of the many very well run licensed premises on the Island, where they will be treated well and looked after by their hosts. All of this creates a good impression of Barry Island Resort being a vibrant, safe, family friendly resort and entertainment facility in the town.

There is absolutely no need for an off license on our lovely seafront, and the application should be refused.

It will therefore be bad for other surrounding businesses who are reliant on families, teenagers and other visitors who want to enjoy the beach without being drunk.

Drunk young people combined with the beach and rocks could be a recipe for tragedy too.

The glass litter on Whitmore Bay is already a horrible problem, and I don't let my children on there ever with bare feet. This needs to be taken seriously - rather than further enabled through selling glass bottled alcohol to people intent on getting drunk.

Please reject this.

PUBLIC SPACE PROTECTION ORDER 2021

ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014

The Vale of Glamorgan Council (the Council) in exercise of its powers under Sections 59 and 72 of the Anti-social Behaviour, Crime and Policing Act 2014 (the Act) and under all other enabling powers, herby makes the following Order:

- 1. This Order shall come into effect on **7**th **December 2020** and shall have an effect for 3 years thereafter, unless extended by further Orders under the Council's statutory powers.
- 2. This Order relates to the specified areas listed in the below Schedule.
- 3. The Council is satisfied that the conditions set out in Section 59(2) of the Act have been met. Namely that alcohol related anti-social behaviour and criminal activities have been carried out within the specified areas. This behaviour has a detrimental effect on the quality of life of those in the locality, and it is likely that these activities will be carried out within that area and has such effect.
- 4. The Council is also satisfied that the conditions set out in Section 59(3) of the Act have been met. Namely, that the effect or likely effect of the activities is, or is likely to be, of a persistent or continuing nature and that these activities are unreasonable and justify the restrictions imposed by this Order and that it is in all the circumstances expedient to make this Order for the purpose of reducing crime and/or anti-social behaviour in a public place.

Restrictions

1. The effect of this Order is to impose the following conditions on the Restricted Area:

- 1.1 In the Restricted Area a person commits an offence if without reasonable excuse he or she continues to carry out activities from which he or she is prohibited, namely;
 - 1.1.1 Continuing to drink alcohol when required to stop doing so by an Authorised Officer.
 - 1.1.2 Not surrendering any alcohol in his or her possession when required to do so by an Authorised Officer.

Correspondence is welcomed in Welsh or English/Croesewir gohebiaeth yn Gymraeg neu Saesneg

- 1.1.3 Refusal to hand over any containers (sealed or unsealed) which are believed to contain alcohol, when required to do so by an Authorised Officer.
- 2. An 'Authorised Officer' can be a Council employee, a person designated by the Council, a Police Officer or Police Community Support Officer who is authorised in writing by the Vale of Glamorgan Council for the purposes of giving directions under this Order.

Fixed Penalty Notice and Offences

- 1. It is an offence for a person without reasonable excuse to engage in the activities restricted on this Order.
- 2. In accordance with Section 63 of the Act, a person found to be in breach of this Order by consuming alcohol when asked not to do so or by refusing to surrender alcohol to an authorised person is liable on summary conviction to a maximum penalty of a level 2 fine.
- An authorised person may issue a Fixed Penalty Notice to anyone he or she believes has committed an offence. You will pay a reduced Penalty if paid within 14 days. If you pay the Fixed Penalty Notice within 29 days you will not be prosecuted.
