To Whom it may concern,

On the 15th January 2022 I inspected the works at The Old Bank, Dinas Powys. I can confirm that the

construction of the ceilings at The Old Bank is:

- a suspended ceiling 250mm below the existing ceiling.
- The suspended ceiling contains 150mm of sound batt insulation.
- Capped with acoustic plasterboard.
- over-boarded with fire rated plasterboard.

A later inspection I witnessed:

- The ceiling had been finished with a skim coat of plaster.
- Decorative timber moulds
- Paint was to be completed from here.

Please note: when the property was used as a bank there NO sound insulation in place. We have greatly improved the build quality of this old building.

Product standards used on site explained:

- Laboratory testing of 100mm of Rockwool Sound Batt Insulation shows to insulate at least

40db of sound. - Testing of standard acoustic plasterboard shows to insulate sound of at least 36db.

BS8233 (2014) – "Guidance on sound insulation and noise reduction for buildings", state that a floor

or ceiling should block airborne sounds of at least 43db.

Taking into considering the above it is quite evident that the insulation and acoustic board installed to the old bank is more than sufficient to obtain standards outlined (sound and

airborne noise) in BS: 8233:2014 thus protecting neighbouring properties as much as possible.

Further improvement works undertaken:

- Restoration of original timber front doors
- Restoration of bathstone to external elevation
- Improved fire safety measures including Fire Alarm GradeA Panel system
- Emergency lighting installed throughout including basement
- Old rotting windows replaced in replica sash woodgrain style to keep the design within keeping of the Village
- Removal of asbestos floor tiles

• Fire boards and 1 hour protection methods used in entire floor to ceiling construction of the 2000sqFT footprint.

- New electrical wiring placing an outdated system
- Total refurbishment of the premises
