Report Title:	Monitoring Officer Meetings with Clerks of Town and Community Councils
Purpose of Report:	To provide the Committee with an update of the meeting held on15th June 2022 undertaken between the Monitoring Officer and Clerks of Town and Community Councils

Executive Summary:

- One of the roles of the Standards Committee is to promote and maintain high standards of conduct by Councillors, Co-opted Members and Church and Parent Governor representatives of the Council.
- To assist in this process, the Monitoring Officer has held meetings with Clerks of Town and Community Councils to provide opportunities for discussion of matters of mutual concern, to have regard to the principles of standards in public life and to provide networking opportunities.
- During the pandemic the Clerks meetings were put on hold, however meetings have since resumed with two taking place in 2021 on 21st May 2021 and 24th November 2021 and the latest having been held on 15th June 2022.

Recommendation

 That the Standards Committee Members considers and notes the report in respect of the Monitoring Officer's meeting with Clerks held on 15th June, 2022.

Reason for Recommendation

1. Having regard to discussions held at the meeting on 15th June, 2022.

1. Background

- **1.1** The Monitoring Officer has previously informed the Standards Committee of the intention to hold six monthly meetings with Clerks of Town and Community Councils to provide a formal opportunity to discuss matters of mutual concern, to provide open discussion and networking opportunities
- **1.2** In 2019 the meetings commenced and two meetings were held on 22nd March, 2019 and 10th October, 2019.
- **1.3** At the first meeting in March 2019, Town and Community Councils' Clerks were provided with a copy of the current Public Services for Wales Ombudsman's Guidance on the Code of Conduct for Members of Community Councils. The Guidance refers to the principles of standards in public life, with specific reference to the need to register Members' interests and have regard to the provisions under gifts and hospitality. The Monitoring Officer suggested that the Clerks, if they had not already done so, share the Guidance with Elected Members of their Town and Community Councils.
- 1.4 It was also noted that through One Voice Wales, Town and Community Councils have access to legal and general advice when they subscribe to the organisation. One Voice Wales is described as a principal organisation for Town and Community Councils in Wales providing a strong voice, representing the Council's interests and a range of high-quality services to support their work. It is the Monitoring Officer's understanding that 25 out of the 26 Town and Community Councils in the Vale of Glamorgan subscribe to the organisation.
- **1.5** Feedback received following the meetings was that meetings were both useful and informative and a frank exchange of views shared which they were grateful to the Monitoring Officer for hosting.
- **1.6** Matters previously discussed at such meetings included those detailed below.
- Finance matters including Council Tax Banding and Precept Setting and funding opportunities for electric car power points
- Becoming a Councillor initiative
- General Power of Competence (GPoC) with the Monitoring Officer drawing attention to an information paper that had been provided to the Senior Leadership Team regarding the provision under the Local Government and Election (Wales) Act 2021 in relation to GPoC

- Member safety with the Monitoring Officer drawing attention to a report that had been presented to the Vale's Democratic Services Committee on 22nd November, 2021 which set out guidance for Members' personal safety and lone working
- Generic observations following the viewing of TCC meetings by Independent Members of the Standards Committee
- Hybrid working and broadcasting of meetings
- Independent Review of Ethical Standards Framework in Wales
- Local Government and Elections (Wales) Act 2021 with the Monitoring Officer drawing attention to reports and the Vale of Glamorgan Council's Action Plan that had been presented to various Vale of Glamorgan Council Committees of the Council including the Community Liaison Committee
- Audit Wales Public Interest report: Sully and Lavernock Community Council
- Sharing of good practice.

2. Key Issues for Consideration

- **2.1** As a result of the pandemic the meetings with Clerks were put on hold and resumed on 19th May, 2021.
- 2.2 The agenda for the meeting on 15th June 2022 included the following items
 - The Vale of Glamorgan Council's Ethics and Standards Training presentation slides
 - Member's Code of Conduct Training hosted with One Voice Wales
 - Acceptance of Office and Member' Code of Conduct Undertaking
 - Public Services Ombudsman for Wales' Guidance
 - Generic observations at Town and Community Council Meetings by Independent Members of the Standards Committee
 - Pending visits from Independent Members
 - General Members' Code of Conduct issues and options for addressing
 - Local Government and Elections (Wales) Act 2021
 - Vale of Glamorgan Council's Whistleblowing Campaign.
- **2.3** The Monitoring Officer will provide detailed verbal feedback to the Standards Committee at its meeting on 23rd June regarding the issues raised / discussed at the Clerks meeting on 15th June 2022.

3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

3.1 The role of the Standards Committee is to promote and maintain high standards of conduct by Councillors, Co-opted Members and Church and Parent Governor representatives. It was intended that the Monitoring Officer meetings with
